Processing of personal data

The Swedish Internet Foundation is an independent public-benefit organization that promotes the positive development of the internet. The Swedish Internet Foundation is responsible for the internet's Swedish top-level domain .se and the operation of the top-level domain .nu. The Swedish Internet Foundation wants to enable innovation and drive the use of the internet forward, while offering digital education and knowledge. To this end, The Swedish Internet Foundation holds several events and runs several services, for example, Broadband check (Bredbandskollen), Internet Days, the Internet Fund and Goto 10.

The Swedish Internet Foundation is, according to the applicable data protection legislation, the personal data controller for personal data processed in connection with The Swedish Internet Foundation's areas of responsibility, events and services.

If you have registered a .nu domain, you will find information on how The Swedish Internet Foundation processes your personal data in the domain name register for .nu [here](#).

If you want to take part of any of The Swedish Internet Foundation's events and services, you can read about how your personal information is processed during each event or service.

Newsletter

The Swedish Internet Foundation is also, according to the applicable data protection legislation, responsible for personal data that is processed on this website. From here, you can order a subscription to a newsletter about one or more of The Swedish Internet Foundation's events and services.

The purpose of the processing of the personal data you provide is for The Swedish Internet Foundation to be able to administer and send newsletters that may contain information and offers on The Swedish Internet Foundation's services. The legal basis for the processing is your consent.

Your personal information is only saved as long as you are a subscriber to the newsletter. When you unsubscribe, The Swedish Internet Foundation will remove your personal information. You can unsubscribe by using the link at the end of the newsletter or email.

The Swedish Internet Foundation may disclose your personal information to partners that The Swedish Internet Foundation uses to administer and send out newsletters. Otherwise, your information is not disclosed, with the exception of meeting the applicable law, legal process or mandatory authority request.

Your rights

You have the right to request, for free, registry extracts that contain the personal information The Swedish Internet Foundation handles about you.

You have the right to request correction of incorrect information. You also have the right to request that your personal data be deleted or that its use be limited, but in this case, there must be support for this in relevant data protection legislation.

You have the right to object to the processing of personal data if the law allows. If your personal data is only processed by your consent, you always have the right to withdraw such consent.

You also have the right to request personal information that you have provided in a structured, generally used and machine-readable format, but then there must be support for this in relevant data protection legislation.

If you wish to request rectification, deletion, limitation of processing, access to personal data or use of the right to extract from the information you have provided yourself, you do so at The Swedish Internet Foundation's data protection agent, dataskyddsbud@internetstiftelsen.se.

If you no longer want to receive The Swedish Internet Foundation's newsletter, you can choose to terminate the service by using the link at the end of email messages or newsletters.
