

Requesting information from the domain name register

The Swedish Internet Foundation is responsible for the Swedish top-level domain .se, with the registration of domain names and administration and technical operation of the national domain name register. The Swedish Internet Foundation also manages the operation and administration of the top level domain .nu. The Swedish Internet Foundation maintains a register of assigned .se and .nu domain names.
